Tewkesbury Town Council welcome that such a document is in development. However, we feel further work is required because the terms of the document are quite weak and the policy should be proactive rather than reactive.

5. To review the proposed changes to the National Planning Policy Framework and consider a response to the consultation being undertaken by the Ministry of Housing, Communities and Local Government if this is determined to be required

JR presented an analysis of the draft policy, particularly focusing on those features which are most pertinent to future development in Tewkesbury Town Parish. In conclusion, while the document aims to reduce bureaucracy and make it easier to meet future housing needs, there are plenty of safeguards which should enable us to protect our parish from exacerbated flooding, our infrastructure from further stress, and our unique local wildlife habitats from destruction. The document also allows for greater flexibility to seek creative ways of regenerating our town centre.

JR and SR were asked by the committee to prepare responses to the 43 questions contained in the consultation document for discussion at our next meeting.
