P.19.109 To receive an update on the progress of the Borough Plan.

JR and SR attended a meeting of the full Borough Council on 30th July 2019 during which, after a lengthy discussion and some amendments, the Borough Plan was approved. Although it was gratifying to see that the Town Council's feedback, following the consultation last November, had been at least partially addressed it was concerning that



there are discrepancies between the SPD, which the Town Council has endorsed, and the Borough Plan, which it has not. JR and SR met with the Head of Development Services last Monday to discuss these discrepancies and were given verbal assurances that there was no need to be concerned. An email confirming this, in addition to a letter of comfort addressed to the Clerk, were promised but have not yet been forthcoming. JR is to send a reminder to the Head of Development Services. JR and SR consider that, so long as these discrepancies remain, the Borough's housing strategy is vulnerable to opportunistic action on the part of developers.

There was an assurance from TBC that there will be another consultation period to follow, when we can ensure that any discrepancies are thoroughly addressed. The Town Council will need to follow the progress of the Borough Plan carefully.

There being no further business, the meeting closed at 19:52.
