TEMPORARY TRAFFIC ORDER
VARIOUS ROADS (TEWKESBURY TOWN, TWYNING PARISH)
TEWKESBURY BOROUGH ORDER 2020

WHEREAS the Gloucestershire County Council ("the Council") being the Traffic Authority for various roads in the Tewkesbury Borough as defined in the schedule below ("the Roads") is satisfied that use of the Roads should be prohibited and restricted because works are being or are proposed to be executed on or near them.

NOW THEREFORE the Council in exercise of its power under Sections 14, 15 and 16 of the Road Traffic Regulation Act, 1984, as amended, hereby makes the following Order:-

1. No person shall park nor wait or cause anyone to park nor wait along the Roads throughout the duration of the works;
2. Except for pedestrian access to properties, no person shall proceed nor cause or permit any vehicle to proceed along the Roads;
3. Nothing in Article 2 shall render it unlawful for a vehicle being used for Police, Fire Brigade or Ambulance purposes to proceed along the Roads;
4. Nothing in Article 2 shall render it unlawful for a vehicle being used by a statutory undertaker responding to an emergency situation to proceed along the Roads;
5. The Roads fall in Tewkesbury Town, Twyning Parish within the boundary of the Tewkesbury Borough in the County of Gloucestershire;
6. This Order shall come into operation on the 11th day of June Two Thousand and Twenty and shall continue in force for a period not exceeding eighteen months;
7. This Order may be cited as "Gloucestershire County Council Temporary Traffic Order Various Roads (Tewkesbury Town, Twyning Parish) Tewkesbury Borough, Order 2020".
8. The prohibitions shall only operate when indicated by the traffic signs prescribed by the Traffic Signs Regulations and General Directions 2016.
9. In the event of any inconsistency or ambiguity between the content of this Temporary Order and any existing permanent/experimental Order(s) imposing restriction(s) on the Roads or diversion routes the latter will be suspended for the duration of the works and the provisions of this Temporary Order shall prevail during that period.
