Observations:

The Town Council considers that the proposal is an aesthetically poor choice and in no way reflects what was there before the vegetation was removed. The proposed design would not be conducive to people using Station Road to walk or cycle along especially during the evening. The Town Council suspects that the proposed screen would be prone to having graffiti sprayed on it. The Town Council therefore concurs with the opinion of Mr Goodchild. The Town Council think that a better alternative would be a hedge of shallow rooted evergreen shrubs with temporary Herras fencing until the shrubs produce good screening.
