

**GLOUCESTERSHIRE COUNTY COUNCIL TEMPORARY CLOSURE
OF VARIOUS ROADS FOR TEWKESBURY CHRISTMAS LIGHTS 2022
(TEWKESBURY TOWN) TEWKESBURY BOROUGH
SPECIAL EVENT ORDER 2022**

WHEREAS the Gloucestershire County Council (“the Council”) being the Traffic Authority for various roads in Winchcombe Town as defined in the Schedule below (“the Roads”) is satisfied that traffic along the lengths of the Roads should be prohibited for the purpose of facilitating the holding of a relevant event namely the Tewkesbury Christmas Lights 2022.

NOW THEREFORE the Council in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic Regulation (Special Events) Act 1994), hereby makes with the Consent the following Order:-

1. Except for pedestrian access to properties, no person shall proceed nor cause or permit any Vehicle to proceed along the Roads;

2. In this Order –

“Motor Vehicle” means a mechanically propelled vehicle intended or adapted for use on the Roads as defined in Section 185 of the Road Traffic Act 1988

“Vehicle” means a Motor Vehicle or any other vehicle unless specifically exempted by the provisions of this Order;

3. Nothing in Article 1 shall render it unlawful for a Vehicle being used for Police, Fire Brigade or Ambulance purposes to proceed along the Roads;

4. Nothing in Article 1 shall render it unlawful for a Vehicle being used by a statutory undertaker responding to an emergency situation to proceed along the Roads;

5. The Roads fall in Tewkesbury Town in the Tewkesbury Borough in the County of Gloucestershire;

6. This Order shall come into operation on the 20th day of November Two Thousand and Twenty Two and shall continue in force for a period in accordance with the Consent;

7. This Order may be cited as “Gloucestershire County Council Temporary Closure of Various Roads for Tewkesbury Christmas Lights 2022 (Tewkesbury Town) Tewkesbury Borough Special Event Order 2022”.
