## REGISTER OF MEMBERS' INTERESTS

### NOTICE OF DISCLOSURE OF PECUNIARY AND OTHER INTERESTS

I, Jessica Baddams a Member of the Tewkesbury Town Council ("the Town Council"), set out below under the appropriate headings the interests which I am required to declare under the Localism Act 2011 and the Town Council's Code of Conduct and I have put 'none' where either I have no such interests under any heading or I am unaware of such an interest.

### PART A

#### DISCLOSABLE PECUNIARY INTERESTS

Any payment or provision of any other financial benefit (other than from the Town Council) made or provided within the last 12 months in respect of expenses you (or any of the persons referred to above) have incurred in carrying out your duties as a Member or towards your election expenses. This includes any payment or financial benefit from a Trade Union within the meaning of Trade Union and Labour Relations (Consolidation) Act 1992.

**3. CONTRACTS**

Any contract which is made between you or the persons referred to above (or a body in which you or they have a beneficial interest) and the Town Council a) under which goods or services are to be provided or works are to be executed; and b) which has not been fully discharged.

Any beneficial interest in land which is within the area of the Town Council (this includes your home or any land or buildings from which you, or the persons referred to above, receive rent).

ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or the persons referred to above, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

- 3) fail to provide written notification to the Monitoring Officer of any change in my interests contained in this Notice within 28 days of my becoming aware of such change of circumstances.
