  also include a link to our interactive parish map and the National Planning Data
  Map.

#### P.25/26.159 To consider budgetary requirements for the year 2025-2026 and the forward budget

With the Strategic Local Plan still in the formative stage, and lots of potentially large local applications in the pipeline (M5 J9, the Garden Town, Mitton Bank, etc), the Town Council needs to be in a position whereby it can call upon expert advice if necessary. It is foreseen that by the end of this financial year there will be a significant earmarked reserve to fund that advice so we believe we can reduce the allocation for Planning Consultancy in next year's budget to £3,000. This is also bearing in mind that, when devolution happens, the Council may seek delegated authority to manage and determine small local applications, in which case, advice and training g will be required.

In order to continue progress with the forward plan it is considered that the Community Development and Outreach budgets should remain as they are currently. As far as this committee can see at the moment, there is no reason to suppose that the budgets for years 2 and 3 should be any different from next year's budget.
